- Existing and finished grades shall be shown at Lot corners and at corners of proposed Improvements. Lot drainage provisions shall be indicated, as well as cut and fill details, if any appreciable change in the Lot contour is contemplated.
- □ The structural design, exterior elevations, exterior materials, colors, textures, and shapes of all improvements shall be described, along with any diagrams or representations necessary to depict the proposed improvements.
- □ A complete material list and photos.
- □ Indicate type, color, and other specifications of the product to be used, such as "GAF Timberline Weathered Wood Shingles,", "BEHR Beige Stain #34555". Include a photo, color swatch, or brochure of each product to be used.
